”The book, studies, articles and communications elaborated and published represents the materialisation of the entire didactic and research activity from a life time span. Among them I shall iterate only some: The Mobility of labour force; The training and using of the labour force; The employment and efficient using of labour force; Retribution – the leverage to use the labour force; The labour market and the durable development; The Romanian scientific research methodology:

- some studies were premiere in Romania like: the unemployed people behaviour, the behaviour of labour force, processes from the sphere of employment and unemployment. (International Comparative Analysis), the formation and spending of the labour market budget; contribution to improvement of the labour market budget and others.

- Some of those studies were required and published by OECD, others were used by Government, as support to the Strategy for development on medium term of Romania and for the integration in the European Structures, others were published or are in train to be published”. As *synthesis book that bring together ample contributions of the author is: “The labour market and the durable development” rewarded with the Economy Prize P.S. Aurelian of Romanian Academy for the year 2003;*

- the theoretical and methodological studies elaborations regarding the determination off the minimum income level and its operationalization in monthly studies, were disseminated to entire Romanian society (Government, Parliament, Presidency, Employers, Syndicate and political parties);

- the study regarding the economic intelligence models, in fact mechanisms used by countries for national economy protection in contemporaneous conditions;

- Elaboration from the Government assignment of the social part from the Government Strategy in the period 1992-1996;

- Coordination of some Reports for Romania regarding the social state and the women status for the Worldwide Reunion from Copenhagen – march 1995 and respectively Wien, 1994 and Beijing 1995;
