Mission

- * grounding and participating to the development strategy of the social protection area
- * **reaching** the scientific objectives of the national and European programs
- * **elaborating** studies and research both with fundamental theoretical nature and with practical-applicative nature, that will answer the requests regarding the grounding and the development of legislative, institutional, methodological and procedural base in its research area
- * elaborating studies and research answering to its own research area demands

General Objectives

- * promoting the social management, nationally as well as regionally and locally, by applying the most significant research and studies' results
- * **developing** an efficient system of social security
- * stimulating the partnership approach for the solving of the problems raised by the economic reform in the field of social assistance
- * harmonizing the Romanian legislation to the UE legislation in the area of social protection

Specific Objectives

- * **designing** indicators, criteria, models and methods of evaluation, both of the social environment and of the social policy on the short, medium and on the long term
- * **elaborating** variants of strategies and action programs in the social area, in order to achieve a social environment that will be competitive from the European point of view
- * **proposing** mechanisms and politics for their instrumentation in order to create a viable and efficient market economy
- * **elaborating** both diagnosis of the social phenomenon and social risks and prognosis of these phenomena in order to ground the social policies in an efficient and efficacious manner
- * **proposing** methods, techniques and strategies of social risks' prevention and elaborating programs for the improvement of living conditions
- * evaluating and structuring the impact of economic, environmental, legislative and institutional factors on the social area


- * policies regarding social inclusion and social cohesion

Specific expertise area


- * studying the social phenomena poverty and its extreme forms: severe poverty, extreme poverty, marginalization and social exclusion
